### **Code of Conduct for Governing Body**

1. The Governing Body sanctions and accepts the proposals passed by the Academic Council of the college.
2. The Governing Body establishes admission rules in accordance with the state government's reservation policy.
3. It possesses complete administrative autonomy and the authority to appoint both administrative staff and teaching faculty.
4. The Governing Body formulates guidelines for Institute scholarships, studentships, medals, prizes, and certificates.
5. The Governing Body adheres to a neutral and unbiased approach towards all its stakeholders.



## **Code of Conduct for Principal**

1. The Principal serves as the head of the Institution, overseeing all administrative and academic activities with a sense of pride and dedication.
2. Impartiality and fairness towards students and staff are key traits expected from the Principal.
3. The Principal ensures compliance with all rules and regulations set forth by the GDR Educational Society.
4. Various co-curricular and extracurricular activities are held concerned with the Principal to enhance students' overall development.
5. Faculty development programs are initiated by the Principal to foster the growth and progress of the teaching staff.
6. The Principal actively works towards the continuous development of the college, guided by its mission and vision.
7. Being hospitable and respectful to higher authorities and stakeholders is an essential aspect of the Principal's role.
8. Encouraging a sense of welfare and fostering mutual trust among all members associated with the college is a priority.
9. The Principal plays a pivotal role in maintaining and promoting diverse academic activities within the college, including research initiatives, publications, seminars, conferences, and workshops. Adequate support, both infrastructural and financial, is sought to facilitate these endeavors.

### **Code of Conduct for Faculty**

1. Faculty members are expected to show respect towards all their higher authorities.
2. Faculty members must adhere to the academic calendar, being punctual for teaching sessions and timely submission of academic materials.
3. Maintaining decorum both inside and outside the classroom is essential for faculty members, and they should enforce discipline during examinations and within the college premises.
4. Faculty members should ensure that students adhere to the prescribed dress code, and physical punishment is strictly prohibited.
5. Implementation of the teacher-guardian mentoring scheme and successful organization of assigned co-curricular and extracurricular activities are responsibilities of the faculty members.
6. Before going on leave, faculty members should make necessary arrangements for their classes and inform higher authorities accordingly.
7. Faculty members are encouraged to publish conference and journal papers under the college's name and actively participate in faculty development programs to enhance their academic growth.
8. In the event of leaving the institute, faculty members should provide one month's notice to the management, and the institute retains the right to relieve them during the notice period, if necessary.

**Code of conduct for students:**

1. Students are required to carry their college identity card at all times and present it when requested by any college authority for verification purposes.
2. Entry into the college premises without the prescribed college uniform is strictly prohibited, as it forms an integral part of the code of conduct.
3. When interacting with teaching staff, non-teaching staff, or any visiting guests on the campus, students should demonstrate respectful behavior, etiquettes, and maintain a professional body language.
4. The use of abusive, critical, or arrogant language by students within the college campus is strictly forbidden.
5. Regular attendance in classrooms is compulsory, and students are expected not to skip classes.
6. Students must handle lab equipment with care and avoid causing any direct or indirect damage to them.
7. Engaging in ragging or any form of sexual harassment of fellow students is strictly prohibited.
8. Students must refrain from mishandling or tampering with library books, college computer systems, or any other college property; any such actions will result in penalties.
9. The Girl's Common Room is designated for the exclusive use of female students.
10. Maintaining peace and order inside and around the college campus is the responsibility of every student, and they should refrain from causing any disturbances.
11. Engaging in games, even in small groups, anywhere in the college premises during lecture hours is not allowed.

**Subject: - Establishment of Durg Vishwavidyalaya, Govt. Vasudev Vaman Patankar Girls' P.G. College Campus, Raipur Naka, Durg, Chhattisgarh as a State University.**

Sir,

With reference to your letter No. 36/2015 dated 28.12.2015 on the above subject, I am directed to say that **Durg Vishwavidyalaya, Govt. Vasudev Vaman Patankar Girls' P.G. College Campus, Raipur Naka, Durg, Chhattisgarh** has been established by an Act of State Legislature of Chhattisgarh as a State University vide Act No. 16 of 2015 and notification No. 3715/D.140/21-A/Praru./C.G./15 dated 24.04.2015 and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 through its own departments, its constituent colleges and/or through its affiliated colleges in regular mode with the approval of statutory bodies/councils, wherever required.

The University is not allowed to start any off-campus centre beyond the territorial jurisdiction of the State as per Hon'ble Supreme Court Judgment in Prof. Yash Pal vs State of Chhattisgarh case.

The University may note and adhere to the following: -

- (i) To ensure that no off campus centre(s)/study centre and the centres operating through franchises is opened by the University outside the territorial jurisdiction of the State in view of the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal vs. Government of Chhattisgarh.
- (ii) In case the university has already started any off-campus/study centre and the centre operating through franchises outside the State, it must be closed immediately.
- (iii) No distance education programs shall be started without the prior approval of UGC.
- (iv) M.Phil/Ph.D programs can be conducted as per the provisions of UGC (Minimum Standards and Procedure for Awards of M.Phil/Ph.D. Degree) Regulations, 2009.

I am enclosing a copy of UGC (Fitness of Certain Universities for Grants) Rules. The detailed information in the prescribed format (attached) may please be sent to this office for considering the proposal to declare University fit to receive Central assistance under Section 12B of UGC Act, 1956.


